ON CCTV IT SHOWS AT 12:32 PM THE SUSPECTS ENTERING THE SAFE DEPOSIT AREA OF BUSINESS. SUSPECT 1 IS THEN OBSERVED REPOSITIONING THE SECURITY CAMERA TO PREVENT ANY RECORDINGS OF THEM COMMITTING THE OFFENSE. SUSPECTS ENTERED THE SAFE VAULT AREA THROUGH A SECURED METAL DOOR BY UNKNOWN MEANS. THERE WAS NO VISIBLE DAMAGE DONE TO THE SECURITY DOOR. ONCE INSIDE THE SUSPECTS DAMAGED SEVERAL SAFE DEPOSIT BOXES AND TOOK UNKNOWN PROPERTY WITHOUT THE CONSENT OF COMP. RP AND WITNESS 1 WENT TO THE SAFE DEPOSIT AREA AT APPROXIMATELY 13:10 PM AND OBSERVED SUSPECT 1 INSIDE OF THE VAULT. RP ASKED SUSPECT WHAT HE WAS DOING INSIDE? SUSPECT 1 THEN REPLIED "I AM HERE WITH MICHELLE." SUSPECT 1 THEN ASKED RP TO OPEN THE SECURITY DOOR OF VAULT SO THAT HE COULD EXIT. RP THEN OPENED THE SECURITY DOOR AND BOTH SUSPECTS FLED THE LOCATION. WITNESS 2 THEN OBSERVED BOTH SUSPECTS FLEEING THE BUILDING ON FOOT. WITNESS 1 THEN NOTIFIED POLICE. PES WAS NOTIFIED. R/O NOTIFIED DETECTIVE SHELTON OF CAPERS, WHO CONTACTED THE FBI. AGENTS OF FBI RESPONDED TO THE SCENE. RP AND WITNESS 1 WERE TRANSPORTED TO CAPERS. RP AND WITNESS 1 ADVISED CAPERS DETECTIVE THAT THEY DID NOT FEEL THREATENED OR IN FEAR OF THEIR LIFE. (SGT HULTQUIST 6873 WAS THE SUPERVISOR OF THIS INCIDENT. END OF ELEMENTS
